---

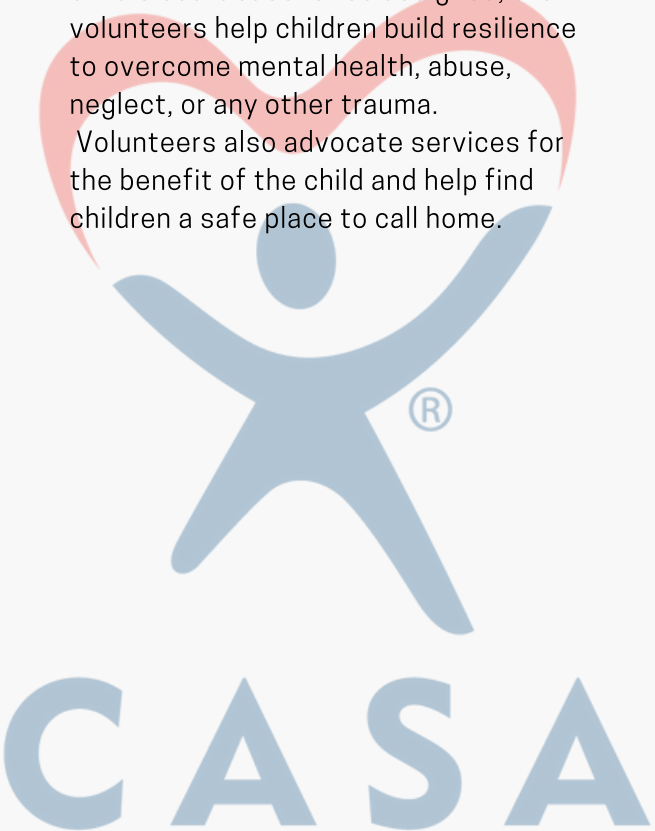
